

CHECKLIST FOR TEMPORARY VISITOR - JAPAN eVISA

(Tourism. Period of stay: up to 90 days)

As listed on eVISA site	Description of the items required
Facial photo	ID photo , taken within the last 6 months. Photo must have a plain background.
Passport	Image of the ID page (the page which shows your photo, name, DOB and passport validity)
Itinerary with flight information	Flight information for journey to and from Japan (if not yet booked, skip to next category)
Documents to prove the ability to pay for travel expenses	Bank statements covering the last 3 months with sufficient funds for the proposed trip. Credit card statement or proof/certificate of balance is not acceptable. If you are submitting your family's bank statement, please include the following: <ul style="list-style-type: none">● Proof of relationship (eg. Birth/Marriage Certificate, family registration)● Bank account holder's government issued photo ID
Schedule of stay	Detailed Schedule of Stay that covers each day of the proposed trip, including places and activities planned during your journey (Sample).
Hotel information	Booking confirmation for your accommodation during your stay in Japan. (if not yet booked, skip to next category).
Certificate of enrolment / employment	Letter from employer or academic institution in the UK (issued within the last 3 months) certifying your employment/enrolment. Job offer letter/contract, payslip or school/university offer letter/tuition fee receipt etc, is not acceptable.
Valid UK eVisa & Share Code / Entry Clearance to prove your immigration status	◆ 'Your immigration status' page printout from www.gov.uk showing your name, ID photo and immigration status and share code (S-- --- ---). OR ◆ Valid UK Entry Clearance / Indefinite Leave to Remain in passport (plus a photocopy).
Parental consent form (if applicable)	If the applicant is under 18, please provide a parental consent letter.
Letter of authorisation (if applicable)	If the application is being submitted by a proxy, the applicant must provide an authorisation letter.

In some cases, additional supporting documents and/or an in-person interview at the Embassy of Japan in the UK in London may be required.

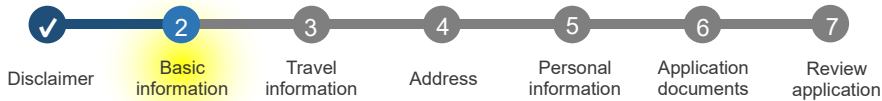
JPG, GIF, TIF, HEIC etc (bitmap image files): multiple files can be uploaded per category.
