Lady Arden, My Lords and Distinguished Guests,

Today, I have the truly wonderful task of honouring Lady Arden of Heswall for her invaluable contributions towards strengthening the relationship and mutual understanding between Japan and the United Kingdom in the judicial field.

It is interesting to note that those Japanese judges who once received her guidance are now playing leading roles in a wide range of fields in the Japanese judiciary.

Furthermore, Lady Arden has also been an excellent supporter of the activities of my embassy. Lady Arden has attended many events organised by the Embassy of Japan in the UK including occasions such as the Emperor's birthday receptions. Lady Arden has also been a regular

participant in the Japanese and British lawyers' networking receptions, which have played a particularly important role in strengthening relationships between British and Japanese lawyers.

It is certainly difficult to describe all of Lady Arden's contributions and achievements towards the judicial relationship between Japan and the UK in a short remark.
