## Remarks by H.E. Mr. HAYASHI Hajime, Ambassador of Japan to the UK, On the Occasion of the Bestowal of The Order of the Rising Sun, Gold Rays with Neck Ribbon Upon Dr Richard Jones Hatchett on 4<sup>th</sup> October 2024

In addition, the global fight against infectious diseases continues as we stand here today. The spread of Mpox, for example, in parts of Africa reminds us of the persistent risks we face. The ever-evolving nature of these threats underscores the importance of relentless progress in vaccine development. I have every confidence that Richard and CEPI will remain at the forefront of this crucial work, playing a leading role in safeguarding global health, advancing the innovations necessary to meet these ongoing challenges and developing international cooperation in these fields.

In view of his magnificent work, Richard is clearly a most worthy recipient of The Order of the Rising Sun, Gold Rays with Neck Ribbon, bestowed upon him by His Majesty the Emperor of Japan. This decoration is the ultimate proof of his dedication and commitment, and is testament to CEPI's resounding achievements.
